





PROJECT REGULATIONS

SUPPORT FOR COOPERATION OF SGGW WITH UKRAINIAN UNIVERSITIES WITHIN THE ALLIANCE OF THE EUROPEAN UNIVERSITY (UNIGREEN UA)

§1. Basic terms and categories

- 1. Whenever this document refers to:
 - UNIgreen UA Project (hereinafter referred to as UNIgreen-UA) it implies the project entitled "Support for cooperation of SGGW with Ukrainian universities within the Alliance of the European University (UNIgreen UA)" implemented within the Agreement no. BPI/UE/2022/12-00 signed with the Polish National Agency for Academic Exchange;
 - SGGW it implies Warsaw University of Life Sciences SGGW;
 - NAWA it implies Polish National Agency for Academic Exchange;
 - Project Participant it implies PhD student or staff of the following Ukrainian universities: National University of Life and Environmental Sciences of Ukraine or Podillia State University, who signed the financial agreement with SGGW for the action carried out within the UNIgreen UA;
 - IRK it implies the recruitment system of SGGW for carrying out the online admission process;

§2. General provisions

- 1. Based on Agreement no. BPI/UE/2022/12-00 signed with NAWA, SGGW received a funding for the UNIgreen UA implementation in the period between **January 1, 2023** and **December 31, 2023**.
- 2. UNIgreen UA aims to carry out activities complementary to the activities undertaken within the framework of the Alliance: The Green European University UNIgreen (https://unigreen-alliance.eu/), to ensure the support for the academic cooperation with Ukrainian universities: National University of Life and Environmental Sciences of Ukraine and Podillia State University.
- 3. Project Regulations define the terms and conditions of participation within the UNIgreen UA, which is addressed to PhD students and staff of Ukrainian universities in accordance with §2, section 2.







4. UNIgreen UA co-finances the following types of action abroad: scientific internships and study visits, of a length of 5 and 90 days respectively, in accordance with §2, section 1.

§3. Specific provisions

- 2. UNIgreen UA co-finances following cost categories, constituting a lump sum in accordance with the Appendix No. 1 to these Project Regulations:
 - subsistence allowance,
 - travel costs,
 - insurance costs.
- 3. UNIgreen UA co-financing for the scientific internship can be assigned to the Project Participant only once.
- 4. UNIgreen UA co-finances of **61 Project Participants**, including:

- 5. The final number of UNIgreen UA Project Participants is a subject to change.
- 6. Steps will be taken to ensure the gender balance within the UNIgreen UA.
- 7. UNIgreen UA will be coordinated by the SGGW's International Relations Office: unigreenua@sggw.edu.pl.







§4. UNIgreen UA call for applicants information

- 1. Information on UNIgreen UA call for applicants will be published on the SGGW website: https://www.sggw.edu.pl/en/unigreen for ua/.
- 2. SGGW coordinates the call for applicants the admission process is conducted separately for applicants for scientific internships and study visits. During the UNIgreen UA call for applicants, the applicants will not be discriminated against on the grounds of gender, age, disability, race or ethnic origin, religion, belief, or sexual orientation.
- 3. Application documents of applicants for the for scientific internship must be submitted online in IRK accessible via website: https://www.sggw.edu.pl/en/unigreen_for_ua/.
- 4. Application documents must be prepared in English language.
- 5. Submission of application documents is a confirmation of being familiarized with Project Regulations and fully accepting its content.
- 6. Participation in the call for applicants requires the provision of correct personal data, in accordance with an identity document. At the same time, it is required that the contact details provided by the applicant enable a quick contact by SGGW.
- 7. Only complete applications submitted in accordance with the recruitment schedule will be considered. Applications submitted after the application deadline will not be considered.
- 8. UNIgreen UA Project Participants are selected in the qualification process based on the evaluation of application documents, which is carried out by the Committee appointed for the duration of the UNIgreen UA.
- 9. Committee, as referred to in §4, section 7, is chaired by the SGGW Vice-Rector for International Cooperation who sets its min. 3 members.

11. After the application deadline, the Committee evaluates the application documents and establishes a ranking list of applicants based on the selection criteria:

- 12. The collective evaluation is calculated by summing up the points awarded to the applicant.
- 13. In the case of awarding the same number of points to several applicants applying to the same university, the Committee may take into account the gender balance in the project as an additional supplementary criterion.
- 14. Call results will be announced within 2 weeks from the application deadline. Information will be distributed to applicants email addresses. The list of co-financed scientific internships will be in addition published on the following website: https://www.sggw.edu.pl/en/unigreen_for_ua/.
- 15. The applicant is not entitled to appeal against the decision of the Committee.

§5. UNIgreen UA Project Participant responsibilities

- 1. UNIgreen UA Project Participant is obliged to:
 - 1) submit online introductory survey,
 - 2) sign a declaration of participation in UNIgreen UA the template of which is an Appendix No. 2 to these Project Regulations,
 - 3) sign a financial agreement the template of which is an Appendix No. 3 to these Project Regulations,
 - 4) present insurance policy for review,
 - 5) inform SGGW on an ongoing basis of circumstances affecting the implementation of the provisions of the Project Regulations and the financial agreement referred to in §5, section 1, point 4.
- 2. UNIgreen UA Project Participant, within 7 days from the ending date of the action, is obliged to:
 - 1) submit a certificate the template of which is an Appendix No. 4 to these Project Regulations,
 - 2) submit a report the template of which is an Appendix No. 5 to these Project Regulations,
 - 3) submit online evaluation survey,
 - 4) sign a settlement form.
- 3. UNIgreen UA Project Participant acknowledges obligation to mark all prepared works, materials and documents created under or in connection with UNIgreen UA and to inform about the source of funding, in particular by using the NAWA logotype.
- 4. UNIgreen UA Project Participant acknowledges obligation to transfer to NAWA economic copyrights to all works created as part of UNIgreen UA by 31 December 2023, under the restriction of returning the received funds. The statement regarding the transfer of economic copyrights is an integral part of the financial agreement referred to in §5, section 1, point 3.

§6. Final provisions

1. Project Regulations are valid in the period as referred to in §2, section 1.

2. The final interpretation of the Project Regulations in disputable matters belongs to the Committee.

The parties have agreed to the following terms of the Agreement:

PROVISIONS OF THE AGREEMENT

§1 SUBJECT-MATTER OF THE AGREEMENT

- The parties have jointly agreed to implement a mobility abroad, hereinafter referred to as the "Action", in compliance with the Agreement BPI/UE/2022/12-00 for the implementation and financing of the UNIgreen UA concluded between SGGW and the Polish National Agency for Academic Exchange.
- 2. SGGW will provide the Project Participant co-financing during the implementation of the Action.
- 3. The Project Participant accepts the co-financing as specified in the §3, section 1 and undertakes to carry out the Action in line with this Agreement and Project Regulations.
- 4. The Project Participant declares that they have read and accept the terms of this Agreement and Project Regulations. Any amendments to this Agreement must be made in writing under the penalty of becoming null and void.

§2 ENTRY INTO FORCE AND DURATION OF THE ACTION

- 1. The Agreement shall enter into force on the date of its conclusion, i.e., after signing by last of the parties.

§3 CO-FINANCING OF THE ACTION

- 2. Within the period of 7 days from the completion of the Action, the Project Participant is obliged to:

 - 2) submit the online evaluation survey,
 - 3) sign the financial settlement.
- 3. The received co-financing or a part thereof shall be repaid if the Project Participant does not carry out the Action in compliance with the terms of the Agreement. If the Project Participant terminates the Agreement before it ends or in the event of a breach of the terms of this Agreement he/she shall have to refund the amount of the co-financing already paid, except if agreed differently with SGGW.

§3 PAYMENT ARRANGEMENTS

- 1. The Project Participant shall receive the agreed co-financing within 7 days following this Agreement's entry into force amounting to ... PLN.

- 3. SGGW shall pay the Project Participant the outstanding balance within 14 days from the date of submission of documents, referred to in the § 3 section 2.
- 4. If the amount of co-financing provided to the Project Participant pursuant to the §3 section 1 exceeds the amount payable indicated in the financial settlement, the Project Participant is obliged to return difference between the amount paid and the amount payable, within 7 days following the day of the SGGW's approval of the financial settlement or from the expiry of the last day on which such financial settlement of the trip should be submitted. The funds returned by the Project Participant, referred to in the previous sentence, are the unused funds under the Agreement BPI/UE/2022/12-00.

§4 TRAVEL ARRANGEMENTS

- 1. Costs of visa (if applicable) will be covered by the Project Participant.
- 2. Travel and insurance arrangements will be made by the Project Participant.
- 3. The Project Participant shall have <u>adequate insurance coverage</u>³. The minimum insurance coverage for the duration of your stay in the destination country should include emergency medical treatment and assistance insurance, personal accident insurance and travel luggage insurance. The Project Participant declares that they have read and accept the terms of the owned insurance policy.

DATA PROTECTION OFFICER (DPO)

The DPO can be contacted for all matters relating to the processing of your personal data by Warsaw University of Life Sciences – SGGW and the exercise of your rights in respect of data processing.

PURPOSES AND LEGAL BASES FOR PROCESSING; DATA RETENTION PERIOD SGGW collects personal data for the following purposes:

- enabling you to set up an account in the Online Application System (IRK-SGGW). An Online Application System account is required to submit the application to the UNIgreen UA. We only collect those personal data in the Online Application System that we are authorized to process in accordance with the Higher Education and Science Law Act of 20 July 2018 and the secondary legislation made thereunder and the relevant Resolution of the SGGW Senate under Article 6(1)(c) GDPR;
- entering into an electronic service agreement (pursuant to the Electronically Supplied Services
 Act of 18 July 2002), including registering and maintaining a free candidate account in the Online
 Application System and enabling access to the available functionalities (legal basis: Article
 6(1)(b) GDPR), i.e. for the "performance of a contract";
- asserting claims under the contract (legal basis: Article 6(1)(f) GDPR), i.e. for the purposes of "legitimate interests"; the time limits for asserting contractual claims are detailed in the Polish Civil Code;
- providing communications for the purposes of rendering services offered through the Online Application System (legal basis: Article 6(1)(f) GDPR), i.e. for the purposes of "legitimate interests".
- handling applications of admitted candidates, including providing communications related to admission to the programme of choice (legal basis: Article 6(1)(f) GDPR), i.e. for the purposes of "legitimate interests";
- handling complaints about electronically supplied services (Article 6(1)(f) GDPR), i.e. for the purposes of "legitimate interests"; and
- additionally, subject to your voluntary consent, your personal data may be used beyond the legal bases mentioned above (legal basis: Article 6(1)(a) GDPR), i.e. under your "consent".

We will retain the data for a definite period determined by any further stages of the admission process. This means that:

- if you set up an account in the Online Application System, then we will process your data until the successful completion of the admission process and, subsequently, if you remain a student, your data will be retained in accordance with the course of your studies and the relevant laws whereunder your data will be retained for 50 years (obligation to retain student records), and any accounting records will be retained in accordance with the accounting laws;
- if you abandon the account set up process in the Online Application System, then we will not keep your data and thus we will not process those data;
- if you are not admitted to the University, then we will retain your data until the end of the admission process or until the closing of the appeal procedure; or







• if your data are processed on the basis of your consent, then you have the right to withdraw your consent to data processing at any time, for data processed under your consent. If you choose to exercise that right, we will cease to process such data and the data will be erased. The withdrawal of consent shall not affect the lawfulness of data use during the period in which the consent was valid.

DATA RECIPIENTS

Access to your personal data will be provided to authorized staff of Warsaw University of Life Sciences – SGGW, including members of admission boards who will process your data in relation to the admission process, as well as the University's associates and entities supporting admissions, including those with whom appropriate data processing agreements have been signed in relation to email services (Microsoft) and for 2nd cycle programs and if interviews or competency assessment tests via Moodle or Microsoft Teams are scheduled.

DATA TRANSFERS OUTSIDE THE EUROPEAN ECONOMIC AREA (EEA)

As the Microsoft services are used, data may be transferred outside the European Economic Area (EEA), including to the United States. Microsoft provides guarantees resulting from compliance with Chapter 5 GDPR and participates in the EU–U.S. Privacy Shield (under Commission Implementing Decision (EU) 2016/1250 of 12 July 2016) and also uses standard contractual clauses. YOUR RIGHTS IN RELATION TO DATA PROCESSING

We guarantee the exercise of all your rights under the terms and conditions provided in the GDPR, i.e. the right to:

- access and receive a copy of the personal data held about you;
- have your personal data rectified (corrected);
- have the processing of your personal data restricted;
- have your personal data erased (except as set out in Article 17(3) GDPR);
- withdraw your consent to data processing, which shall not affect the period before such withdrawal;
- lodge a complaint with the President of the Personal Data Protection Office if you believe that the data processing violates the data protection laws.

OBLIGATION TO PROVIDE DATA AND CONSEQUENCES OF REFUSAL

It is necessary to provide personal data to be able to take part in the admission process. For other data not necessary to take part in the admission process, providing such data is voluntary.

§6 TRANSFER OF AUTHOR'S ECONOMIC RIGHTS

- 1. As of the balancing payment date, the Project Participant shall transfer to SGGW their author's economic rights to the work, and such transfer shall take place throughout the universe in perpetuity, and concern any and all copies of the works and the following fields of use:
 - Fixing, copying, uploading to computer memory and computer network servers;
 - Public broadcasting and displaying at seminars and conferences;
 - Presenting in publications and in all types of audio-visual and computer media;
 - Multiplying by means of printing or fixing on a magnetic storage device or in the electronic form;
 - Marketing;
 - Disseminating the copies of the work for free;







- Using the work, in whole or in part, and in combination with other works, creating derivative works by means of adding different elements, updating, modifying, translating into foreign languages, changing the colours or the size of the entire work or parts thereof;
- Uploading the work, in whole or in part, to the Internet in a way enabling interested users to access it, and also storing the work in the computer's RAM;
- Publishing or disclosing the work, in whole or in part, in a video or audio format, using the Ethernet or wireless network and via terrestrial or satellite television.
- 2. The Project Participant shall transfer to SGGW the right to exercise derivative rights and the right to consent to the exercise of derivative rights to the work in the fields of use listed in section 1.
- 3. The transfer of the author's economic rights to SGGW in the fields of use listed in section 1 shall be executed as part of the Project funding.
- 4. The Project Participant represents that the work completed and delivered is free from any defects in materials/workmanship and title defects, and that they only enjoy author's economic rights to the work to the extent necessary to transfer the same to SGGW, and that these rights are not limited in any way whatsoever. The Project Participant also represents that the use of the work does not violate any industrial or intellectual property rights, particularly those covered under patents, copyrights or trademarks.
- 5. The Parties agree that in the event of any third-party claims concerning the work, the Project Participant, upon having been advised by SGGW thereof, shall seek to clarify the matter and defend the claim, at their own expense and risk, and pay any legitimate claims to SGGW and in the case an obligation to pay any damages has been imposed on SGGW under a court decision the Project Participant shall reimburse SGGW for all damages it paid to settle such third-party claims, and for any expenses and fees it incurred, including the costs of legal proceedings and other legal costs. The Project Participant shall fulfil the obligations referred to in the foregoing only if the grounds for the claim concerning the work are attributable to the Project Participant.
- 6. If the work is not free from title defects or if the Project Participant is responsible for the occurrence of the aforementioned events that preclude the use of the work and the exercise of the rights vested in SGGW, the Project Participant shall, before the deadline agreed on by the Parties in due course, deliver the work in a version free from any defects and compliant with the requirements set forth in the Agreement, and remedy the losses suffered by SGGW in connection therewith. In the event referred to in the foregoing, SGGW may, instead of requesting the Project Participant to deliver a work free from any defects, terminate the Agreement within 30 days of having learnt about the grounds for such termination, with the effect stipulated in § 5 of the Agreement on project funding, made by and between the Project Participant and SGGW. The withdrawal from the Agreement does not release the Project Participant from the obligation to pay damages for the loss suffered.
- 8. The Parties commit not to exercise the rights vested in them in a manner restricting the exercise of the rights by the other Party.
- 9. The Project Participant commits not to register as trademarks any visual, verbal or audiovisual works being part of the work covered by the Agreement.
- 10. When requested by SGGW, the Project Participant shall deliver the copies of the work to SGGW on a durable medium named by the University. The title to the durable medium on which the work has been fixed and delivered shall also be transferred to SGGW as part of the Project funding.

§7 APPLICABLE LAW AND JURISDICTION

Granting and payment of the agreed co-financing under the UNIgreen UA shall be made in observance of the provisions of this Agreement, while considering the provisions of the Project Regulations and Agreement no. BPI/UE/2022/12-00







Agreement BPI/UE/2022/12-00. Any disputed matters relating to this Agreement shall be settled in accordance with the Polish legislation.

§8 FINAL CONDITIONS

- 1. The court with jurisdiction to resolve any disputes arising from this Agreement will be the court competent for territory of Poland.
- 2. This Agreement has been drawn up in two identical copies, one for each party.
