

DOCUMENTS CERTIFYING THE KNOWLEDGE OF ENGLISH

The candidates are obliged to provide one of the following documents certifying their knowledge of English on B2 level or higher according to global scale of „*Common European Framework of Reference for Languages: learning, teaching, assessment (CEFR)*”.
