

Regulations of the photography competition entitled "Erasmus through the lens", hereinafter referred to as the "Competition",

for students of the Warsaw University of Life Sciences

(hereinafter referred to as the "Regulations")

§ 1 GENERAL PROVISIONS

1. The organizer of the Competition is the Warsaw University of Life Sciences, hereinafter referred to as the "Organizer", correspondence address: Warsaw University of Life Sciences, ul. Nowoursynowska 166, 02-787 Warszawa, and the organizational unit responsible for its proper implementation is the International Relations Office.
2. The participants of the Competition may be students of SGGW who participated/are participating in the mobility of the Erasmus+ Program (Applies to exchange studies and internships).
3. The Organizer's employees and their closest relatives cannot participate in the competition. The closest persons within the meaning of the Regulations are persons with whom the Organizer's employees are married, consanguinity or affinity in the direct line, consanguinity or affinity in the collateral line up to the second degree, or are related by virtue of adoption, guardianship or guardianship.
4. Participation in the Competition is voluntary and free of charge.
5. The competition will be announced on the Organizer's website: www.sggw.edu.pl/category/aktualnosci-wspolpraca-miedzynarodowa-bwm. The Regulations and all information about the Competition, changes in the Regulations and other messages for the Competition Participants will be posted on the indicated Organizer's website in entry dedicated to the Competition. The answers, explanations and information provided in this way will be binding on all Competition Participants.
6. Participation in the Competition is tantamount to acceptance of the terms and conditions set out in these Regulations, including the declarations of the Competition Participant indicated in its content.

§ 2 PURPOSE AND SUBJECT OF THE COMPETITION

1. The aim of the Competition is to promote the Erasmus+ Program among SGGW students.
2. The subject of the Competition are self-taken photos along with their description, related to the Competition Participant's participation in the Erasmus+ program, and the detailed conditions regarding the competition works are specified in § 3 of the Regulations.
3. The competition is of an artistic and cultural nature (the competition is in the field of culture and art).

§ 3 COMPETITION ENTRIES

1. The competition entry is a photo taken by the Competition Participant himself, which best reflects what the participation in the Erasmus+ program was like for the given Competition Participant (the topic of the Competition), and a short description of the history of his/her participation in the Erasmus+ program, containing a maximum of ten sentences. Participants submit photos in digital form, photos must be saved in JPG format, minimum 200 DPI. The use of photomontages involving combining photo elements from different files is not allowed.
2. A Competition Participant may submit only one Competition Entry.

3. Applications for participation in the Competition together with the attached Competition Entry should be sent electronically to the following e-mail address: erasmus@sggw.edu.pl by May 31, 2024 (11:59 p.m.), providing the name of the Competition in the subject and the name of the Competition in the content an e-mail message to the Organizer, specifying your personal data in the form of: name and surname, department, e-mail address at which the Organizer will be able to contact you in matters related to the Participant's participation in the Competition, and the name of the host institution where the mobility took place.
4. Competition entries received by the Organizer after the deadline specified in section 3 above will not be qualified for the Competition.

§ 4 COMPETITION RULES, EVALUATION CRITERIA

1. Correctly submitted Competition Entries will be assessed by the Competition Committee, consisting of 3 employees of the International Cooperation Office appointed by the Head of the above-mentioned organizational unit of the Organizer.
2. Competition works will be assessed in accordance with the following evaluation criteria:
 - a) compliance with the theme of the Competition (creativity in the selection of photos is important) – maximum 20 points;
 - b) original, innovative photo concept – maximum 20 points;
 - c) creativity of the description - maximum 10 points.
3. The competition entry can receive a maximum of 50 points. The points awarded by individual members of the Competition Committee according to the criteria indicated above will be added up. If two or more Competition Entries receive an equal number of points, which would determine the award of a place in the Competition, the Competition Committee will make a unanimous decision which Competition Entry will be rated higher and will receive a higher place. The evaluation of the competition entries made by the Competition Committee is final.
4. As part of the Competition, 3 Winners will be selected whose competition works were rated the highest.
5. The prize will be Allegro vouchers worth:
 - a) First place winner – prize of PLN 300
 - b) Second place winner – prize of PLN 200
 - c) Third place winner – prize of PLN 100
6. The competition result will be published on June 21, 2024 on the Fun Page of the SGGW International Cooperation Office on Facebook.
7. The winners will be informed about their winnings by e-mail.
8. Taking part in the competition is tantamount to consenting to the processing and publishing of participants' personal data by the organizer for the purposes of implementing the competition.
9. Sending the Competition Entry to the Organizer by the Competition Participant is tantamount to submitting a declaration that:
 - a) has all proprietary copyrights to it, including those enabling the use and distribution of the work and individual works included in it, for the purposes and in the manner described in the Regulations.
 - b) the use of the Competition Entry or individual works included in it in the manner described in the Regulations will in no way infringe the copyrights and personal rights of third parties;
 - c) has all necessary consents from the persons whose image was recorded in the submitted competition works or individual works constituting the work, and in the case of minors - appropriate consents from their legal guardians for the use of their image by the Organizer in the manner

described in point d and e below, including consent to the processing of personal data in the form of the image of such persons for the purpose and to the extent necessary for the proper implementation of the Competition;

- d) grants the Organizer, without additional remuneration, a non-exclusive license to use the Competition Entry and individual works included in it, in particular photos, without time and territorial limits, in the fields of use listed below, a) subjecting the work to the necessary computer intervention (processing, assembly); b) digital recording, archiving in computer memory and internal network; c) copying on any media; d) making the work publicly available on the Organizer's website, in materials and social media belonging to SGGW in such a way that everyone can have access to it at a place and time of their choosing; e) use of the work in the production of promotional and presentation materials, also as a fragment of one's own production, recorded and reproduced on any media; f) reproduction of the work in any form, including printing;

for promotional and information purposes regarding the Competition and the Organizer's activities within the scope of the subject of the Competition and in accordance with the purpose of the Competition specified in the Regulations.

- e) consents to the use, without additional remuneration, of his image and the image of the persons referred to in point c) above, recorded in the Competition Entry submitted to the Organizer for promotional and information purposes regarding the Competition and the Organizer's activities within the scope of the subject of the Competition and in accordance with purpose of the Competition, via the Internet, including communication channels on the Organizer's social media, without territorial restrictions. In order to avoid any doubts, the above consent covers the subjective and objective scope of the use of the Competition Work by the Organizer for the purposes and under the terms specified in point d) above.
- f) the content and photos used by him do not violate the rights of third parties, personal rights, and do not contain content contrary to public order or moral values;
- g) has read the content of the GDPR Information Clause, constituting Annex No. 1a to these Regulations, addressed to the Competition Participants, and undertakes to inform, on behalf of the Organizer, the persons whose image was recorded by the Competition Participant in the submitted competition entry, about the processing of their image personal data by the Organizer to the extent indicated in Annex No. 1b.

10. Works that:

- a) violate the law generally applicable in the territory of Poland;
- b) violate the rights of third parties;
- c) may violate the personal rights of other people;
- d) contain content generally considered offensive, reprehensible or inappropriate;
- e) do not contain content contrary to public order and moral values;
- f) display trademarks registered in the Patent Office (except for the Organizer's trademarks);
- g) contain advertising content;
- h) violate other provisions of the Regulations.

§ 5 FINAL PROVISIONS

- 1. WULS-SGGW, acting as the Administrator of personal data within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as "GDPR"), informs that it will process personal data provided by the Competition Participants, indicated by the Competition

Participants in the content of the application for the Competition and the competition work submitted to the Organizer, in connection with registering their participation in the Competition on the terms set out in these Regulations, for the purpose and to the extent necessary for the proper implementation of the Competition, with the detailed content of the information clause specifying the scope of data being processed, the legal basis for the processing of such data, the purposes of processing and the rights and obligations of data subjects, constitutes Annex No. 1a to the Regulations. The Competition Participants undertake to provide, on behalf of WULS-SGGW, to third parties whose image was recorded in the photos submitted as part of the competition entry, the information referred to in Art. 14 GDPR, indicated by WULS-SGGW in the information clause constituting Annex No. 1b.

2. The Organizer reserves the right to change these Regulations.
3. The Organizer reserves the right not to select the winners if the artistic value of the submitted photos is low and if the content of the descriptions included in the competition entries violates applicable Polish law, social and moral norms or does not have qualities ensuring the achievement of the purpose of the Competition.
4. In matters not regulated in these Regulations, the provisions of the Civil Code in Warsaw shall apply.
